

## CATHOLIC CHARITIES ALLOCATIONS COMMITTEE

#### PURPOSE

The aim of the Catholic Charities Allocation Committee is to assist with funding Catholic and community organisations who are working in areas identified as priorities by The Tindall Foundation as aligned with diocesan goals.

We are charged, by the Diocese of Palmerston North, with the support of groups committed to social, pastoral, charitable and educational needs in our diocesan region. This region includes Taranaki, Wanganui, Manawatu, Tararua, and Hawke's Bay through to Wairoa. Applications are judged on the basis of need, resource availability and the fulfilment of set criteria.

### PROFILE

#### The Catholic Charities Foundation of the Diocese of Palmerston North ('CCF')

The CCF makes a general grant to the diocese with a percentage of these funds available for distribution by the Catholic Charities Allocation Committee. The CCF is a 'capital fund' for 'special needs' established to assist the pastoral, charitable and educational works of the Church within the diocese. It is a trust fund which provides a vehicle for those who wish to combine contributions with the contributions of others to form a capital base held in perpetuity, the income available for distribution.

#### The Tindall Foundation ('TTF')

TTF makes an annual grant to the New Zealand Catholic Bishops Conference ('NZCBC'). The NZCBC is a Faith-based funding manager for TTF. The Catholic Charities Allocation Committee acts as the NZCBC agent in the Diocese of Palmerston North. TTF's vision is that it should play a supportive role in the philanthropic sector in New Zealand and that it should contribute to healing problems rather than managing them.

### PROCESS

Drawing from its funding base, the Catholic Charities Allocation Committee allocates resources based on criteria as outlined on the criteria information page. Allocations are made in May and November each year and applications close:
